**RECEIVER'S SECOND CLAIM REPORT
AND MOTION FOR ORDER ESTABLISHING FURTHER
ADMINISTRATION PROCEDURES**

COMES NOW Superintendent of Insurance Russell Toal, in his capacity as the New Mexico Superintendent of Insurance ("Superintendent") and as Court-appointed, Receiver ("Receiver ") of New Mexico Health Connections, Inc. ("NMHC"), and hereby submits this second claim report ("Report") as set forth herein, and moves the Court for an order to approve the further administration of the receivership of NMHC ("Receivership") pursuant to the New Mexico Insurers Conservation, Rehabilitation and Liquidation Law, Section 59A-41-1 et seq., NMSA 1978, including objection procedures, as proposed herein ("Liquidation Laws"). In support, the Receiver states as follows:

1. Pursuant to the Court's Order re: *Motion to Approve Notice Plan* entered May 7, 2021 ("Order"), the Receiver has successfully (a) commenced issuing the notices contemplated by the notice plan, in the manner specified in the plan, within seven days of the opening of the proof of claim portal, and (b) issued all e-mail and mail notices contemplated by the notice plan within three weeks of the opening of the proof of claim portal.

2. Generally, the Liquidation Laws require Petitioner, as receiver of NMHC, to collect and liquidate the assets of NMHC, and then distribute those assets according to the priorities enumerated in NMSA 1978, §59A-41-44 (1984). Subsections A through J of Section 59A-41-44 describe various types of claims that a creditor may have against an insurer. Section 59A-41-41(B) NMSA 1978 (1984) requires the superintendent to provide notice to persons who hold any such claim to file a proof of claim “at a place and within the time specified” in a notice provided by the superintendent.

3. Pursuant to a notice plan set forth at paragraph 10 of the first claim report, and as approved in the Order, the Receiver provided notices of determination to all timely claimants on all reported claims. The Receiver provided denial notices to all claimants that did not comply with the Court-approved claims process.

4. In addition to providing notice of the receivership and the proof of claim process, the Receiver also created an electronic proof of claim portal to reduce costs and make the claims filing and adjudication process more efficient. That portal was accessible at <https://osi-claims.osi.state.nm.us/>.

5. After the claims filing deadline, the Receiver reviewed and adjudicated Priority Class A (administration costs) and C (loss claims) claims that were filed in the NMHC receivership. The Receiver previously reported to the Court the Priority Class A (administration costs), and class C (loss claims) against NMHC with the Receiver’s recommendations.

6. The Receiver now reports the Priority Class D and E claims along with two additional Priority Class C claims not known to the Receiver at the time of the filing of the first

claim report, and five Priority Class H claims¹. The Receiver's second claim report ("Second Report") is attached hereto as *Exhibit A*.

7. The Second Report includes two filed claims for Priority Class C (loss claims) in addition to those disclosed in the first claim report; the amount claimed for these additional Class C claims total \$5,456.52. The Second Report also includes 37 filed claims for Priority D (unearned premium), for a total amount claimed of \$29,360.75, 9 filed claims for Priority E (residual classification), for a total amount claimed of \$86,237,075.76, and 8 Priority Class H (late claims), for a total amount claimed of \$29,250.57. Of these amounts claimed, the Receiver recommends an initial total valuation of each of these classes of claims as follows:

- \$2,340.22 for Priority C (loss claims);
- \$0 for Priority D (unearned premium);
- \$0 for Priority E (residual classification); and
- \$0 for Priority H (late claims).

These proposed adjustments to the first claim report are based upon the Receiver's review of the timely submitted claims and all supporting evidence, and comparison to the relevant contract terms, and would be subject to objection and review by the Court, as proposed below. In the interest of efficiency, the Receiver has not currently adjudicated claims in priority classes below the projected distribution level of Class C. In the unlikely event that the distribution level significantly exceeds current projections, the Receiver will timely notify the Court and all affected claimants as soon as practicable.

8. One of the claims included in the Second Report is the claim of the United States Department of Health and Human Services Center for Medicare and Medicaid Services ("CMS

¹ The first claim report noted 54 late claims. These claims and five additional late claims received subsequent to the first claims report are hereby proposed by the Receiver as Class H pursuant to Section 59A-41-44(H).

Claim”). That claim is currently classified as a Priority Class E (residual classification) claim pursuant to Section 59A-41-44 NMSA 1978. The New Mexico statutory priority scheme does not have a separate classification for claims of the federal government.

9. However, the CMS Claim should not be classified with the other Priority Class E (residual classification) claims, and should be only subordinate to administrative and policyholder claims in classes A through D. In 1993, the US Supreme Court ruled that the federal priority statute, 31 U.S.C. §3713, requires claims of the federal government as against an insolvent insurer to be accorded priority over all claims other than administrative claims and policyholder claims. *See, United States Department of Treasury v. Fabe*, 113 S.Ct. 2202, 508 U.S. 491, 493-494 (1993). The Court reasoned that the priorities established by state law only preempted federal law pursuant to the McCarran-Ferguson Act at 15 U.S.C. Section 1012(b) to the extent that it “regulated the business of insurance” in this manner. *Id.*

10. The Receiver thus proposes reclassifying the federal government claim as a Priority Class E(1)-Federal Government Claim ahead of the other Priority Class E claims in the estate. The other Priority Class E claims will be classified as Priority Class E(2) claims. If at the time of the distribution the estate has sufficient funds to pay the Priority Class E claims, the Receiver will pay 100% of any Priority Class E(1) claims before paying any Priority Class E(2) claims.

11. The Receiver proposes the following procedures for providing an initial determination regarding the total value of each claim included in the Second Report prior to any adjustments and any proposed final distribution pursuant to Section 59A-41-44 NMSA 1978, and notice thereof to each claimant:

a. The Receiver will provide a notice of determination (“Notice”) by email or first-class mail to timely claimants on all reported claims in the Second Report within seven

(7) days of the Court's acceptance of this Report. The notice will report the amount claimed, the amount recommended by the Receiver and will describe the objection process the claimant can use if they do not agree with the Receiver's recommendation.

b. The proposed Notice is attached hereto as *Exhibit B*.

c. All objections must be in writing and received by an objection filing deadline of forty-five (45) days of the Court's acceptance of this Report. The written objection must include all documentation to support the claim. The Receiver will attempt to resolve any objections. If a resolution is not reached, the Receiver will schedule an objection hearing with the Court. The Court will not consider any evidence that is not included with the written objection.

d. The Receiver will also send a notice to the five aforementioned claimants with late filed claims advising the claimant that their claim was not filed in compliance with this Court's Liquidation Order and describing the objection process.

e. A copy of the proposed denial notice is attached hereto as *Exhibit C*.

12. When NMHC was placed into receivership, there were uncashed checks remaining on the books. The total amount of these uncashed checks is \$201,486.15. *Exhibit D*. But for the receivership, NMHC would follow the New Mexico escheatment process created by the New Mexico Uniform Unclaimed Property Act, Section 7-8A-1 et seq. In a receivership, however, those funds are assets of the estate and the impacted creditors and the state of New Mexico have claims in the Receivership for the amounts owed pursuant to NMSA 1978, §59A-41-41 (1984).

13. However, the Receiver will provide notice to the New Mexico Taxation and Revenue Department that it may have a claim for the amounts of certain uncashed checks held by NMHC as of the date of the appointment of the Receiver. In the interests of fairness and noting

that the Receiver did not recognize this issue at the time he provided notices to all potential claimants, the Receiver respectfully proposes that such notice shall be provided to the New Mexico Taxation and Revenue Department within ten (10) days of an order approving this Second Claim Report, and further requiring a response to such notice provided to the Receiver within forty-five (45) days after receiving such notice. The determination as to which checks would have been presumed as abandoned unclaimed property as of the date of the appointment of Receiver will be subsequently determined by the Court.²

14. After the date of liquidation, NMHC continued to receive premiums on 108 cancelled policies as a result of automatic payments that policyholders did not terminate. Such premiums total \$68,387.57. **Exhibit E.** These funds paid premiums for insurance coverage never provided by NMHC, and thus do not belong to NMHC or constitute “claims” for unearned premiums as contemplated by Section 59A-41-44 of the Liquidation Laws. Because the funds do not belong to NMHC, the Receiver recommends immediately returning the funds to the rightful owners. However, the Receiver respectfully recommends that *de minimus* amounts below a five-dollar threshold not be returned because the administrative costs to the Receivership for issuing such returns greatly exceeds the benefits to such owners.

15. The Receiver recommends that the Court “deem file” all broker claims for commissions. These claims total \$778.09. **Exhibit F.** Subsequent to the filing of the first claim report, the Receiver now has access to the records necessary to calculate and adjudicate these claims. Deem filing broker claims is the most efficient and equitable process for administering broker claims.

² The Receiver notes that this determination is likely to depend on the Court’s interpretation of Section 7-8A-2(A) of the Act, specifically, which subparagraph of Section 7-8A-2(A) includes such unclaimed checks, and the corresponding number of years NMHC, as the former holder of such checks, should have continued to hold such checks before reporting them as abandoned.

16. In response to the notices sent by the Receiver as described in paragraph 3, above, the Receiver received a total of 12 objections. Of these objections, all were timely filed by the April 30, 2022 deadline established in the Order.

17. The Receiver respectfully proposes that it serve a proposed adjudication of each timely filed objection to each such objector on or before thirty (30) days after the Court's acceptance of this Report, with notice that any response to such adjudication be both filed with the Court and served on the Receiver no later than thirty (30) days thereafter. The Receiver respectfully proposes that the Court will then adjudicate such objections with an opportunity for such objectors to be heard at a hearing no later than ninety (90) days thereafter.

18. With respect to any subsequent objections pursuant to any notices ordered by the Court pursuant to the Second Report, the Receiver anticipates proposing similar procedures as those outlined above.

WHEREFORE, based on the forgoing, the Receiver respectfully requests that the Court enter an order as follows:

- a. approving the Second Report set forth herein;
- b. approving the classification of all federal government claims as Priority Class E(1)-Federal Government Claim ahead of the other Priority Class E claims in the estate;
- c. approving the proposed claim procedures as set forth herein;
- d. directing all persons with standing to object to this Second Report and proposed further administration, to wit, all persons who have filed claims, as herewith reported to the Court, to file any objection that they may have to this Second Report with the Clerk of this Court on or before 11:59 p.m. thirty (30)

days after the Court's acceptance of this Report, and requiring that a copy of said objection be served on the Receiver at:

and to deny all objections not so filed;

- e. approving the treatment of uncashed checks as set forth above;
- f. approving the Receiver's recommendation to immediately return the mistakenly transmitted post liquidation premiums greater than five dollars as set forth above;
- g. approving the Receiver's proposal to deem as properly filed all broker claims as described above;
- h. approving the procedures for resolving all currently pending objections as set forth in paragraph 16-17, above; and
- i. granting such other and further relief as the Court deems just.
